# Government intends to exempt Carer's Allowance claimants from benefit cap.

In a debate in the House of Lords on Monday night, the government announced that it intends to exempt everyone who gets <u>Carer's Allowance</u>from the benefit cap that applies to out-of-work households. Families are already exempt from the cap if they have a dependent child on <u>Disability Living Allowance</u> or <u>Personal Independence Payment</u>.

However, if a disabled child aged 16 or above either leaves education, turns 20 or claims certain benefits such as Employment and Support Allowance, they stop being treated as a dependent child and <u>start</u> being treated as an adult. Until now this has meant that their parent could lose their protection from the benefit cap at that point. Once this new rule is introduced, parents will <u>continue</u> to be exempt from the benefit cap even if they are looking after an adult son or daughter rather than a dependent child. This will be the case so long as the parent is getting Carer's Allowance.

This announcement follows a recent High Court decision, which found that the failure to exempt those on Carer's Allowance looking after a disabled adult amounted to unlawful discrimination.

#### WHAT IS THE HOUSEHOLD BENEFIT CAP?

The household benefit cap limits the total amount of benefits that an out of work family can receive. At the moment the cap is £500 per week for lone parents and couples and £350 per week for single people. However, in April 2016 the government intends to lower these figures to £442 (£296 for single carers without dependent children) in London and to £385 (£258 for single carers without dependent children) elsewhere. It is likely that there will be a large increase in the numbers of households affected by the cap once it is lowered. If your benefit income is above the cap then the excess amount is cut from your housing benefit payments. The benefit cap will also be a feature of the new Universal Credit.

#### Stop the DLA takeaway in hospital

Disability Living Allowance (DLA) payments are stopped when a child is in hospital for more than 84 days. The government justifies stopping DLA when a child spends a long time in hospital by arguing that a child's needs are fully met free of charge by the NHS. Research shows that without a parents' input, a child's needs are not fully met in hospital and the extra costs continue. That's why we think these rules denies families financial help when they need it most.
